

## **IDEMNITY FORM**

We, the undersigned, hereby acknowledge that we are entering a wildlife area at our own risk. We fully understand and appreciate that there are risks involved with wildlife areas and game lodges arising from amongst other things the presence of wild, unpredictable and dangerous animals, insects and reptiles.

Whilst on Silonque Nature Reserve/Silonque East, the Estate, the premises, property and/or using the facilities, in the car, on foot, by bike, in and outside the accommodation or at general areas, we will not hold Silonque Holiday Estate (hereafter named SHE), it's members, Board of Trustees and or Managing Agent, employees and/or contractors responsible or liable for:

- the loss or damage of property or possession of any guest (or accompanied minor), even if such damage is caused by the negligent act or omission of Silonque Holiday Estate, its members, employees, contractors or the Board of Trustees.
- any bodily injuries, loss, damage or death of whatsoever nature sustained by a guest (or accompanied minor), whether such injuries are caused behaviour of any animal in the reserve, wild or otherwise; fire, theft, criminal act, or negligent act or omission Silonque Holiday Estate, its members, employees, contractors or the Board of Trustees and/or by the defective functioning of any apparatus.

We understand that:

- Silonque Holiday Estate is in an area where dangerous animals roam freely and malaria may occur;
- We shall not make fires unless in areas demarcated for that purpose and at all times keep safety as a priority whilst watching carefully for bushfires and extinguishing fires at all times when not around;
- We shall not collect firewood from the bush;
- We shall not approach, interact, shoot, chase, feed or harm any animal and at all times give them right of way;
- We shall not drive or traverse on any parts of the Silonque East/Silonque Nature reserve and on the Estate other than on clearly defined roads as all plots are private properties and this is considered as trespassing by the rightful owners;
- We shall not exceed a speed of 20 km/hour when travelling on the Estate, Silonque East/Silonque Nature reserve;
- We shall only park in clearly designated parking areas as it causes damage to the Estate and to the natural bush. Children under 16 years **shall always** be accompanied by an adult on the premises of the Estate;
- We shall try to preserve the future sustainability of Silonque Holiday Estate as a whole and will make sure that garbage at all time is in the garbage containers, leave the common premises in a clean condition and make sure not to leave plastic, rubbish or food around as not to attract any animals or endanger wildlife or nature.
- We must respect the quiet hours between 20h00 and 07h:00 and not create a disturbing noise. Not at any time should the volume of music, electronic equipment a/o instruments, entertainment or be at such level as to cause a nuisance or disturbance to any other Member or wildlife on the estate;

We have read and understand this indemnity agreement and its condition which are binding.
